

SUMMARY OF COMMUNITY RELATIONS STAKEHOLDER IDENTIFICATION

As part of community relations stakeholder identification activities for the former Closed Loop property at 2200 Fairwood Avenue, EnSafe Inc. contacted members of the community identified by staff of the Ohio Environmental Protection Agency (Ohio EPA) during July and August 2019. Stakeholder identification activities generally included the following:

- Notification that EnSafe had been retained to prepare plans for removal of cathode ray tubes and electronic wastes from this property.
- Notification that development of the plans was being coordinated with Ohio EPA and the Ohio Attorney General's office.
- Notification that there were steps taken to secure the buildings.
- Request for confirmation of the stakeholders' contact information so that EnSafe would be able to provide copies of the closure plan documents to them upon completion.
- EnSafe's Edward "Ned" B. Baker provided his contact information to each person to facilitate responses to any questions that may arise following the initial outreach. This contact information generally included Mr. Baker's office or mobile phone (216-274-0112 // 216-924-2437). When requested, Mr. Baker also provided his email address (nbaker@ensafe.com).
- EnSafe is mailing copies of the closure plan documents to these stakeholders to facilitate their comments.

As part of the community relations efforts for the planned removal action at the former Closed Loop property at 2200 Fairwood Avenue, the tenants in the portion of the warehouse property that was not leased to Closed Loop have been advised of the following:

- The plan for the removal action.
- That a public comment period will soon commence that will allow members of the public to comment on the closure plan documents.
- The projected timing for commencement of activities described in the closure plan documents.
